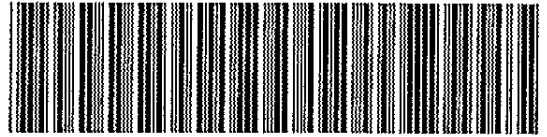

The undersigned incorporator hereby forms a corporation under chapter 607 of the laws of the State of Florida.

ARTICLE 1- NAME

The name of this corporation is 4TH GENERATION PRODUCTIONS, INC.

ARTICLE 2- PRINCIPAL OFFICE
