The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

#### ARTICLE I

# Name and Business Address

Section 1.1 Name. The name of the corporation is FS LA SAUCE INC. 2239 Coca Ave., Middleburg, FL, 32068.

# **ARTICLE II**

# **Duration**

<u>Section 2.1.</u> <u>Duration.</u> This corporation shall exist perpetually. Corporate existence shall commence after these Articles are filed with the Secretary of State's Office.

#### ARTICLE III

#### Purposes

<u>Section 3.1. Purposes.</u> This Corporation is organized for the purpose of transaction any or all lawful business permitted under the Laws of the United States and of the State of Florida. Specifically practicing sale food services.


