ARTICLE I - NAME AND ADDRESS

The name of this corporation is **SARONG INCORPORATED** (the "Corporation").

The Corporation shall indemnify any officer or director, or any former officer or director of the Corporation, to the fullest extent permitted by law.


ARTICLE X - AMENDMENT
