ARTICLE XI- AMENDMENT

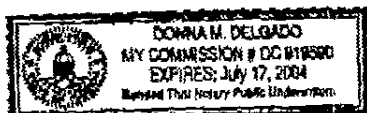

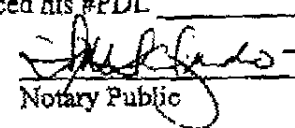
