
ARTICLE THIRTEEN



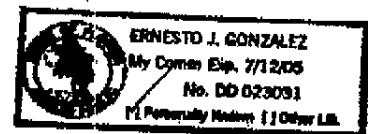
