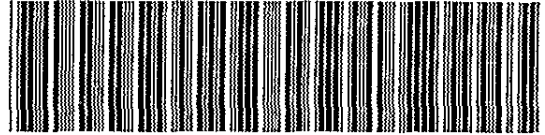

ARTICLE I NAME

The name of the corporation shall be CREATURE COMFORTS PET SITTING, INC.

ARTICLE II PURPOSE

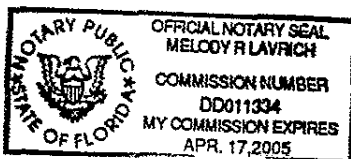
