

## ARTICLES OF INCORPORATION OF RTF INSURANCE INSPECTIONS, INC.



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE:

The name of the Corporation is RTF INSURANCE INSPECTIONS, INC.
