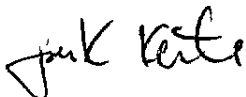

ARTICLE I - NAME

The name of this Corporation shall be:
Montoya Manufacturing, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on 03/15/03.

ARTICLE XI - INDEMNIFICATION

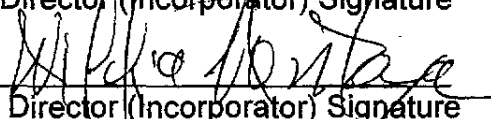

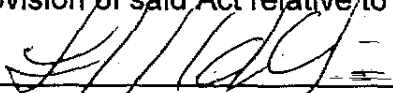
