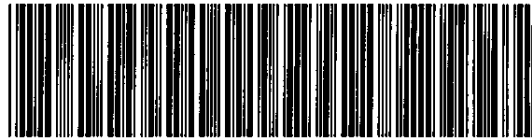

2. This amendment changes the name of this corporation to **RHH ENTERPRISES, INC.**, and, therefore, old Article I of the corporation's Articles of Incorporation, as previously amended, is hereby deleted and new Article I is added and will read as follows:

ARTICLE I - NAME

The name of the corporation shall be **RHH ENTERPRISES, INC.**
