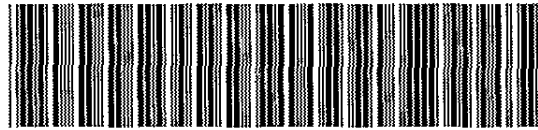

ARTICLE I

NAME: The name of this Corporation is Premier WoodWorks Coast to Coast, Inc., and its address is 380 S. State Road 434, Suite 1004-344, Altamonte Springs, Florida 32714.

ARTICLE II

DURATION: This Corporation shall exist perpetually.

ARTICLE III

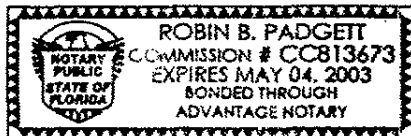
