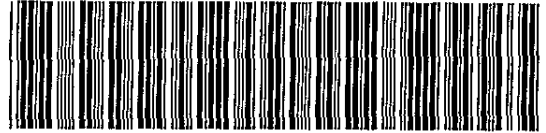

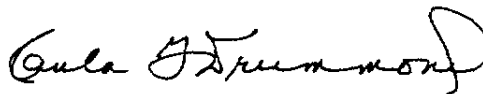

**ARTICLES OF INCORPORATION**

of

THE UNDERSIGNED for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of this corporation is **TECHSCAPE & ASSOCIATES, INC.**

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on April 1, 2003.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of engaging in and transacting any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act, and to do such other things as are incidental to the purpose of the corporation or necessary and desirable in order to accomplish them.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares of which the corporation is authorized to issue is 100 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of the corporation is 2411 Beaumont St, Pensacola, Florida 32504, and the name of the initial registered agent of this corporation at that address is Mary S. Cuneo.

**ARTICLE VI - MAILING ADDRESS OF CORPORATION**

The initial mailing address of this corporation is 2411 Beaumont St., Pensacola, FL 32504.

**ARTICLE VII - INITIAL BOARD OF DIRECTORS**

This corporation shall have one Director constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time in the manner provided

by the bylaws; however, there shall never be less than one director nor more than five. The initial Director is Mary S. Cuneo.

**ARTICLE VIII - INCORPORATOR**

The name and address of the Incorporator is Mary S. Cuneo, 2411 Beaumont St., Pensacola, FL 32504.

**ARTICLE IX - INDEMNIFICATION**

The Corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law.


**ARTICLE X - AMENDMENT**

Except as may be otherwise specifically provided in these Articles of Incorporation, this Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the Shareholders.

**ARTICLE XI - BYLAWS**


The power to adopt, alter, amend and repeal the Bylaws shall be vested in the Board of Directors.
