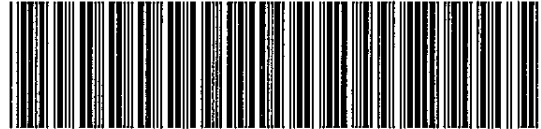

The undersigned, acting as incorporator of **THE FORCE GSE, INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I.
NAME

The name of the corporation is **THE FORCE GSE, INC.**

ARTICLE II.
ADDRESS

The mailing address and principal office address of the corporation is:
5727 Northwest 151st Street, Miami Lakes, Florida 33014.

ARTICLE III.
COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence at 12:01 A.M. on the date of filing of these Articles of Incorporation.

ARTICLE IV.
PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE V.
AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is Six Hundred (600) shares of common stock having a par value of \$5.00 per share.

ARTICLE VI.
INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is **5727 Northwest 151st Street, Miami Lakes, Florida 33014.** The corporation's initial registered agent at that address is **MANUEL NAMUR.**

ARTICLE VII.
INITIAL BOARD OF DIRECTORS

The corporation shall have at least one director. The number of directors may be either increased or diminished from time to time, as provided in the By-Laws, but shall never be less than one.

ARTICLE VIII.
INCORPORATOR
