The Share of the Class A voting stock and the Class B non voting Stock and the preferences ,limitation,and relative rights thereof shall be identical except only that shares of the Class B non voting common stock shall not have any voting rights, while all voting rights of the shareholders will be by the shareholders owning the Shares of Class A voting Stock.

Rights of the Shareholders will be held by the Shareholders owing the Shares of the Class A voting Stock

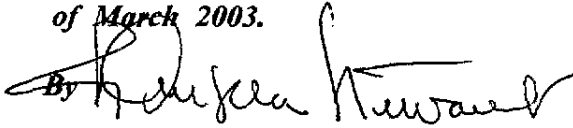
