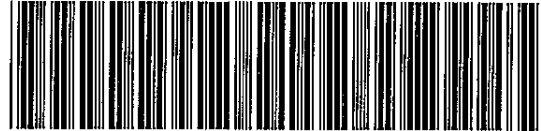

The undersigned, for the purpose of forming a corporation under the Laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of the corporation shall be: Awards For Memories, Inc.

Its business shall be conducted in the United States and its possessions and in all foreign countries, wherever necessary or convenient.

**ARTICLE II. TERM**

The term of existence of the corporation is perpetual.

**ARTICLE III. BUSINESS**

The purpose for which the corporation is organized is to engage in the business of commercial design and printing, and to engage in any lawful business or activities related thereto, or to further engage in any other lawful act or activity for which corporations may be organized under the Laws of the State of Florida.

#### ARTICLE IV. STOCK

The authorized capital stock of this corporation shall be five thousand (5,000) shares of common stock, each share having a par value of one dollar (\$1.00).

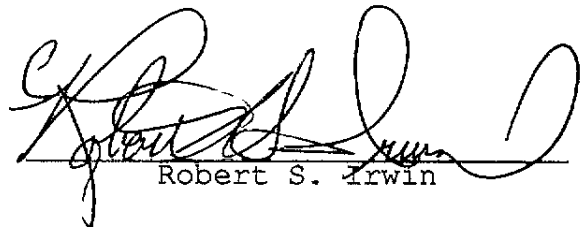

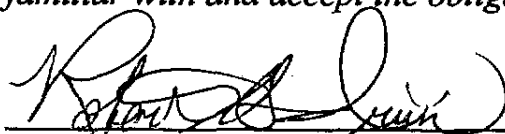
