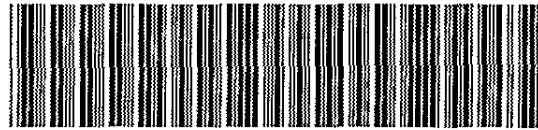

ARTICLE I -- NAME




