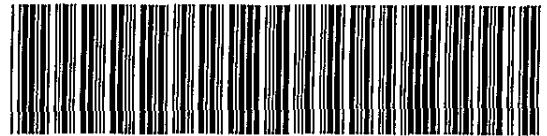

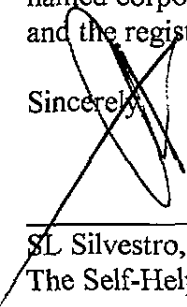

5. The registered agent of the corporation is Michael L. Garrett, and the registered address is: 1312 N. Daytona Avenue, Flagler Beach, FL 32136.

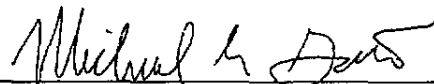
