**ARTICLES OF INCORPORATION**  
**OF**  
**HALIBUT SERVICES, INC.**

**ARTICLE I - NAME**

The name of the corporation is Halibut Services, Inc. (hereinafter called the "Corporation").

**ARTICLE II - PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act of the State of Florida.

**ARTICLE III - CAPITAL STOCK**

The aggregate number of shares which the Corporation shall have the authority to issue is 1,000 shares of Common Stock, par value \$.01 per share.
