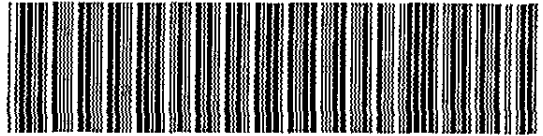

ARTICLES OF INCORPORATION

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

ARTICLE I

Name

The name of the Corporation shall be **TDM FINANCIAL, INC.**

ARTICLE II

Principal Office

The principal office of the Corporation is located at 3672 Biscayne Drive, Winter Springs, Florida 32708.

ARTICLE III

Corporate Purposes, Power and Rights

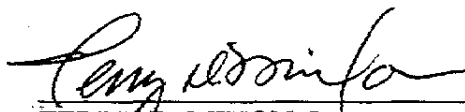
