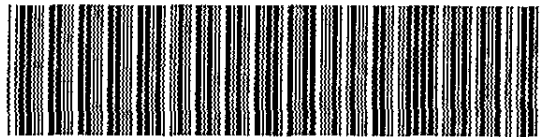

The name of this corporation shall be Stained Glass Curtain, Inc.
