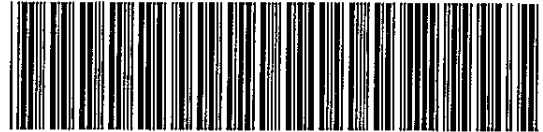

TO THE APPLICABLE LAWS THEREOF. B. TO MANAGE AND TO PROVIDE MANAGEMENT FOR AND SUPERVISE ALL OR PART OF ANY AND EVERY KIND OF BUSINESS ENTERPRISE AND TO CONTRACT OR ARRANGE WITH ANY CORPORATION, ASSOCIATION, PARTNERSHIP, OR INDIVIDUAL FOR THE MANAGEMENT, OPERATION AND SUPERVISION OF ALL KINDS OF BUSINESSES. TO ADVERTISE, PROMOTE, MERCHANDISE AND OTHERWISE PROVIDE THE SERVICES OFFERED HEREIN; TO NEGOTIATE AND CONTRACT WITH RESPECT TO FURNISHING FOR THE SAME FOR OR ON BEHALF OF ANY PERSON, FIRM, OR CORPORATION, DOMESTIC OR FOREIGN; TO ENTER INTO JOINT ARRANGEMENTS WITH OTHER PERSONS, FIRMS, OR CORPORATIONS ENGAGED IN THE LIKE OR SIMILAR ACTIVITIES; GENERALLY TO EXPLOIT THE SERVICES AND OBJECT OF THE CORPORATION BY ALL LAWFUL MEANS.
