I, the undersigned, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I Name and Principal Office

The name of this corporation shall be:

Kinsman Clearwater Properties Corporation

The principal office and mailing address of this corporation shall be One Steinbrenner Drive, Tampa, Florida 33614, or such other address within the State of Florida as the Board of Directors may from time to time designate.

ARTICLE II Existence of Corporation

This corporation shall begin existence effective the 26th day of March, 2003, and shall have perpetual existence.

ARTICLE III Purposes

The purposes for which the Corporation is organized are limited solely to (a) being the general partner of Kinsman Hospitality of Clearwater, Ltd., a Florida limited partnership ("Kinsman Hospitality"), (b) acting as, and exercising all of the authority of, the general partner of Kinsman Hospitality, and (c) the transacting any and all lawful business for which a corporation may be organized under Florida law that is incident, necessary and appropriate to accomplish the foregoing.

ARTICLE IV

General Powers

The Corporation shall have all power and authority to take action and/or otherwise perform in a manner consistent with the purposes set forth above.

ARTICLE V Capital Stock

(a) The total number of shares of capital stock authorized to be issued by the corporation (the "Shares") shall be 10,000 shares of common capital stock having a par value of \$1.00 per share. Each of the said Shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders. All or any part of the Shares may be paid for in cash, in property, or in labor or services actually performed for the corporation and valued at a fair valuation to be fixed by the Board

of Directors at a meeting called for such purpose. All stock when issued shall be paid for and shall be nonassessable.

(b) In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election.

ARTICLE VI Registered Office and Registered Agent

The street address of the corporation's initial registered office is 212 S. Magnolia Avenue, Tampa, Florida 33606, and the name of the corporation's initial registered agent at such address is Mark T. Tate. The corporation may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Section 607.0502, Florida Statutes.
