ARTICLE I

NAME: The name of this Corporation is NEW SONG PARTNERS, INC., and its address is 6025 Allen Street, Mount Dora, FL 32757.

ARTICLE II

DURATION: This Corporation shall exist perpetually.



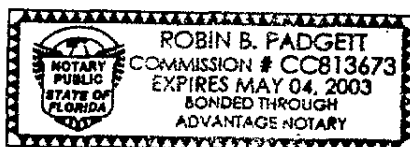


