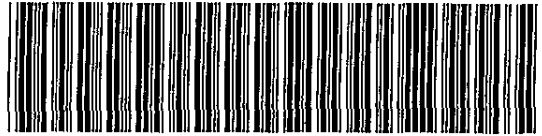

ARTICLE OF INCORPORATION
OF
