TO THE ARTICLES OF INCORPORATION OF

1. He is the President of JONATHAN A. ADLER, M.D., P.A., a Florida corporation, which Articles of Incorporation were filed with the Secretary of State, State of Florida, on March 28, 2003.

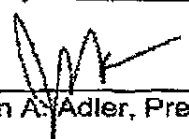
3. Article I of the Articles of Incorporation is hereby amended in its entirety to read as follows:
