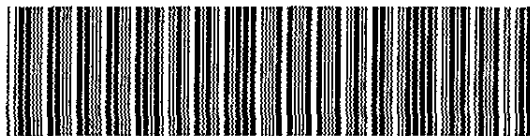

ARTICLE I - CORPORATE NAME AND MAILING ADDRESS
