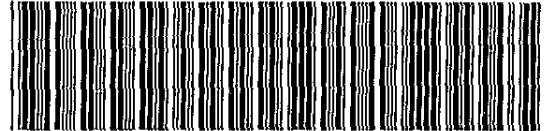

**ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract hereby forms an Incorporated Company under the laws of the State of Florida.

ARTICLE I. NAME

ARTICLE IX. OFFICER/DIRECTOR(s) RIGHT TO CONTINUE BUSINESS

person or entity, and each and every person who may become a director, or officer of the Incorporated Company is hereby relieved from any liability that might otherwise exist from his contracting with the Incorporated Company for the benefit of himself or any firm, association, corporation, or other entity in which he may be in anyway interested. Any director, or officer of the Incorporated Company without regard to the fact that he is also a director, or officer of such entity.


