# ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF BIXI, INC. A FLORIDA CORPORATION P03000036049

Pursuant to the provisions of § 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

First: Amendment adopted:

#### II. BUSINESS

The general nature of the business and business to be transacted are as follows: To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida of the United States.
