**ARTICLES OF INCORPORATION**  
**OF**  
**COLLEGE PARK PEDIATRICS, P.A.**

The undersigned incorporator, for the purpose of forming a professional association, under the Professional Services Corporation Act, hereby adopts the following Articles of Incorporation.

**Article I**  
**Name and Duration**

The name of this professional association is COLLEGE PARK PEDIATRICS, P.A. The duration of the professional association is perpetual. The effective date upon which this professional association shall come into existence shall be the date these Articles are filed by the Secretary of State.

**Article II**  
**Principal Office**

The address of the principal office and mailing address of the professional association in the State of Florida is 531 West Yale Street, Orlando, Florida 32804.

**Article III**  
**Corporate Purposes, Powers and Rights**

The general purpose for which this professional association is organized shall be:

1. To render professional medical services to the general public, and to do all things in connection therewith that are customarily done by physicians under the laws of the State of Florida.
2. In furtherance of its corporate purposes, the professional association shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Professional Service Corporation Act.

**Registered Office and Agent**

**Article VI**  
**Directors**

The power to adopt, amend or repeal bylaws for the management of this professional association shall be vested in the Board of Directors or the shareholders, but the Board of Directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to the amendment or repeal by the Board of Directors.
