

ARTICLES OF INCORPORATION OF
BIG MIKE'S N.Y. STYLE DELI AND PIZZERIA, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

Article I. Name

The name of the corporation shall be BIG MIKE'S N.Y. STYLE DELI AND PIZZERIA, INC.

The address of the principal office of this corporation shall be 2500 North Federal Highway, Fort Lauderdale, Florida 33305 and the mailing address of the corporation shall be the same.

Article II. Nature of the Business
