**ARTICLE I – NAME**

The name of this corporation is POPE PAINTING & REMODELING, INC.

**ARTICLE II – DURATION**

This corporation is to have perpetual existence.

**ARTICLE III**

The nature of the business of this corporation shall be to engage in any lawful business allowed under the laws of the State of Florida, and shall have all of the powers enumerated under Florida Law.

**ARTICLE IV – CAPITAL STOCK**

The capital stock of this corporation shall consist of one thousand shares of common stock having a nominal or par value of Fifty Cents (\$.50) per share. #### **ARTICLE VII – INITIAL PRINCIPAL OFFICE**


The street address of the initial principal office of the corporation shall be Route 2, Box 356 A-4, Lake City, Florida 32024.
