

Articles Of Incorporation

PORTMAN PRODUCTIONS, Inc.

The undersigned, acting hereby as Incorporator for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit, pursuant to Chapter 607, Florida Statutes, and other applicable law, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be PORTMAN PRODUCTIONS, INC. 3860 LAUREL STREET, St. Augustine, Florida 32084, 904-824-6692.

ARTICLE II

DURATION

This corporation shall have a perpetual existence unless sooner dissolved according to law. Upon dissolution of the corporation all assets of the corporation, including real property and bank accounts, shall be given to: LORRAINE PORTMAN, 3860 LAUREL STREET St. Augustine, Florida 32084, 904-824-6692.

ARTICLE III

PURPOSE

The purpose of this corporation is to conduct the business of theater and motion picture production, film production, direction, devolvement and editing business under the Florida General Corporation Act.

ARTICLE IV

DIRECTORS

ARTICLE V
