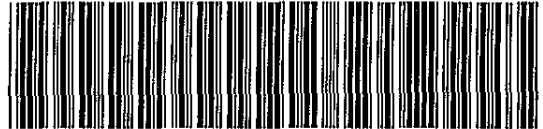

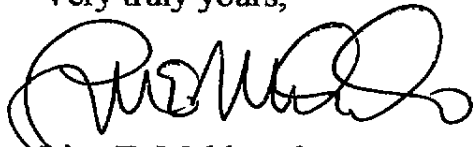

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the Florida General Corporation Act, Florida Statutes, Chapter 607, and other laws of the State of Florida, do hereby certify to the following:

ARTICLE I - NAME

The name of this Corporation shall be **Southern Beach Management, Inc.**
The nature of this business is beach management and any other lawful purpose.

ARTICLE II - ADDRESS

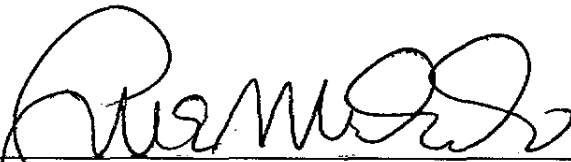

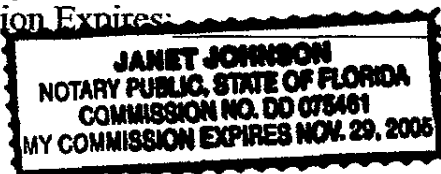
