## **Articles of Incorporation**

#### ARTICLE I

#### NAME

The name of the Corporation is London Builders, Inc.. The principal office address and the mailing address of said Corporation is 10877 Horse Track Drive Jacksonville, Florida 32257.

#### ARTICLE II

#### DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
