#### ARTICLES OF INCORPORATION

OF

The undersigned hereby files these Articles of Incorporation for the purpose of becoming a corporation for profit under the laws of the State of Florida.

#### ARTICLE I.

The name of the Corporation shall be: ALL CITY ELECTRICAL CONTRACTING, INC.

# ARTICLE II.

The general nature of the businesses to be transacted by the Corporation shall be as follows:

To design, devise, invent, manufacture, install, remove, repair, inspect, report upon, buy, sell, handle and deal in electric installation, service machinery, plants, apparatus, appliances, accessories, equipment, supplies, and means and materials, of all kinds, for the generation, production, transmission, transformation, accumulation, storage, distribution, supplying, application and utilization of electricity for all purposes.
