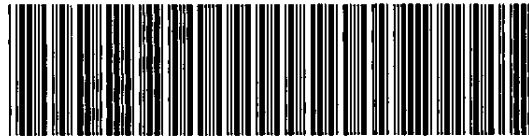



The name of the Corporation is DEPENDABLE POOL SERVICE, INC., which was duly incorporated on March 27, 2003, by the State of Florida.


