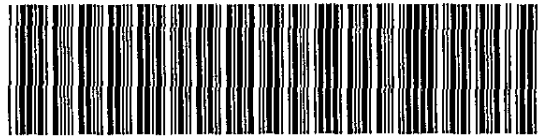

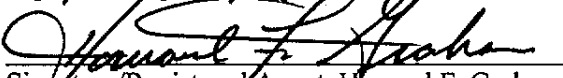

To maintain, operate, or otherwise conduct the business of farming and animal husbandry, to breed, raise, purchase, acquire, buy, sell, let or otherwise deal in livestock or crops, or to purchase, acquire, buy, sell, let, store, or otherwise deal in equipment related to the business of farming, animal husbandry, or construction. To do or cause to be done any and all acts and things necessary, desirable, convenient, or incidental to the consummation and accomplishment of any and all of the purposes and business of the corporation; and in general, to carry on, conduct and operate any of all of the business of the corporation as principal, agent, contractor, or sub-contractor, and to do and carry on any other lawful business or venture, by itself or in conjunction with others, incidental to or in connection with the foregoing; to have an exercise all of the powers, rights and benefits conferred by the laws of the State of Florida upon corporations formed under the laws of the State of Florida, and to do any or all of the things hereinbefore set forth to the same extent as natural persons could or might do in their own right.
