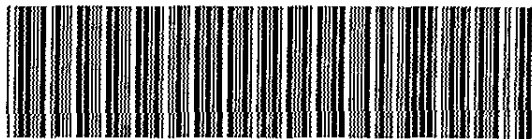

ARTICLES OF INCORPORATION  
OF  
SUNCOAST NETWORK.COM, INC.

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of this Corporation is: SUNCOAST NETWORK.COM, INC.  
The principal place of business of this Corporation is:  
11199 Polo Club Rd., Suite D, Wellington, Florida 33414,  
which is the same as the registered office of this Corporation.

ARTICLE II

This Corporation shall have perpetual existence commencing of the filing of these Articles.

### ARTICLE III

#### PURPOSE

The general purpose for which the Corporation is organized are the following:

- a. To engage in and transact any lawful business for which Corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- b. To do such other things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them.
- c. To engage in the operation of a business dedicated to providing internet information services and to carry on any business necessary or incidental to the accomplishment or furtherance of the purpose of this Corporation.

### ARTICLE IV

#### CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is Ten Thousand (10,000) Shares of

common stock. Such shares shall be of a single class and shall have a par value of One Hundred Dollars (\$100.00) per share.

#### ARTICLE V

##### REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is 11199 Polo Club Rd., Suite D, Wellington, Florida 33414. The name of its initial registered agent at that address is Timothy A. Shaw.

#### ARTICLE VI

##### BOARD OF DIRECTORS

The number of directors constituting the initial board of Directors for this Corporation is one (1). The number of directors may be increased or decreased from time to time in accordance with the bylaws, but shall never be less than one (1). 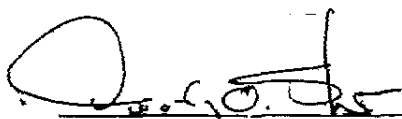
ARTICLE IX

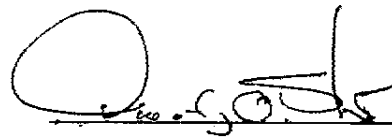
