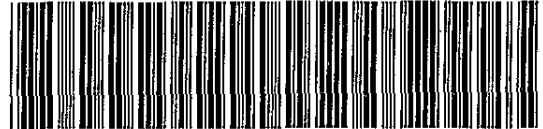

These Articles of Incorporation shall be effective as of the date of filing with the Secretary of State.


ARTICLE IX – POWERS OF CORPORATION
