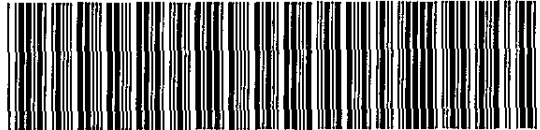

ARTICLE II. NATURE OF BUSINESS AND POWERS



These Articles of Incorporation may be amended in the manner provided by law.



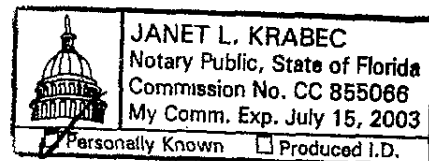
