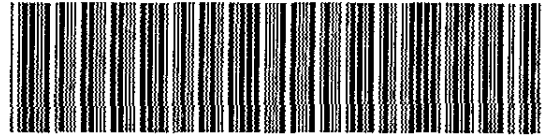

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be CUPID'S CREATIONS, INC., and the initial address of this corporation shall be 80 Commodore Drive, #417, Plantation, FL, 33325.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida, including without limitation, creating, assembling, and selling beaded jewelry, including, but not limited to necklaces, earrings, bracelets or anklets.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
