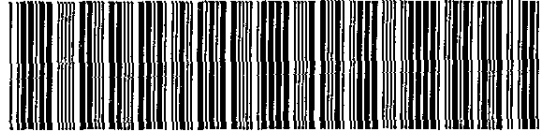



ARTICLE 1

The name of this corporation is Schoolmatch, Inc.

ARTICLE 11

The purpose or purposes for which this corporation is organized is for transacting any and all lawful business.
