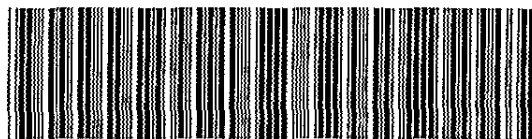



ARTICLES OF INCORPORATION

In compliance with the requirements of Ch. 607, Fla. Stat., the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is HINSKE ENTERPRISES, INC.

ARTICLE II

The existence of the Corporation shall begin upon the filing of these Articles with the Florida Secretary of State.

ARTICLE III

The street address of the principal office of the Corporation is 4517 S. Gains Road, Tampa, Florida 33611.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, par value \$1.00 per share, all of which shall be Common Shares. 
