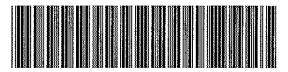

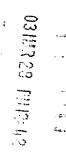

NAME OF BUSINESS

THE UNDERSIGNED Incorporator, for the purpose of forming a corporation for non-profit under the Corporation Act of the State of Florida, does hereby certify as follows:

ARTICLE I: NAME
