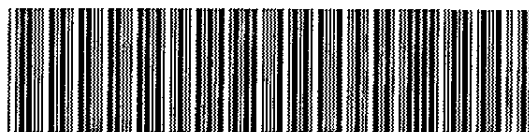

ARTICLE I - NAME

The name of this Corporation is OND, INC.; the address is 4511 THREE LAKE CIRCLE,
ORLANDO, FLORIDA 32808.

ARTICLE II - DURATION

This Corporation shall commence its existence on the 26th day of March 2003 with the filing of
these Articles with the Secretary of State.

ARTICLE III - PURPOSE

This Corporation may engage in or transact any or all lawful activities or businesses permitted

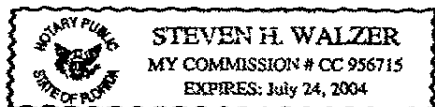
