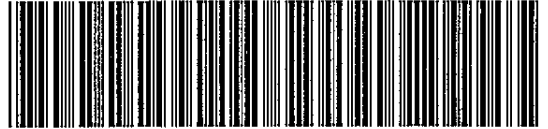

ARTICLES OF INCORPORATION
OF
SHERAEJON ENTERPRISES, INC.

The undersigned subscriber to these Articles of Incorporation, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I
NAME

The name of the corporation is SHERAEJON ENTERPRISES, INC.

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the corporation's principal office is 470 Columbia Drive, Building "B", West Palm Beach, Florida 33409.

ARTICLE III
DURATION AND COMMENCEMENT OF CORPORATE SERVICE

The corporation shall exist perpetually. The corporate existence shall commence upon the filing of these Articles of Incorporation with the Department of State.

ARTICLE IV
NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE V
CAPITAL STOCK

The corporation is authorized to have outstanding one class of stock, to be designated as Common Stock. The maximum number of shares of Common Stock which the corporation is

authorized to have outstanding is 100 shares of Common Stock of a par value of \$1.00 per share. Holders of Common Stock are entitled to vote on all questions required by law on the basis of one vote per share and there shall be no cumulative voting. Holders of Common Stock shall have pre-emptive rights to subscribe to the corporation's securities and are entitled to receive the net assets of the corporation upon dissolution.

ARTICLE VI
INITIAL REGISTERED AGENT AND OFFICE

The name of the initial registered agent of this corporation is Jon D. Derrevere. The street address of the corporation's initial registered agent is 470 Columbia Drive, Building "B", West Palm Beach, Florida 33409.

ARTICLE VII
INITIAL BOARD OF DIRECTORS
