ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is RCDC ENTERPRISES, INC. and its principal place of business shall be located at 7042 Prestwick Circle South, Jacksonville, Florida 32244.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE X - INDEMNIFICATION


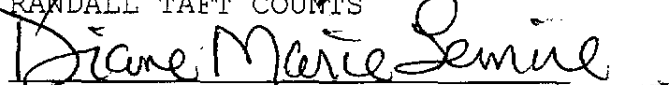

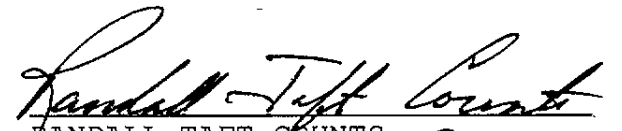
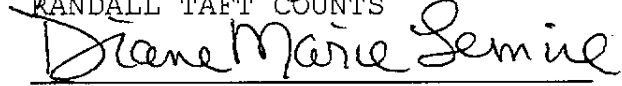
