ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is HAT TRICK'S REDLINE, INC.

ARTICLE II

The existence of the Corporation shall begin on April 3, 2003

ARTICLE III

The street address of the principal office of the Corporation is 1614 N. 28th Court, Hollywood, FL 33020.




