ARTICLES OF INCORPORATION

OF

RIVA CORPORATION

I, the undersigned natural person, acting as incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporations such corporation:

ARTICLE I Name and Address

The name of the corporation is RIVA CORPORATION.
