

THE UNDERSIGNED, incorporator, hereby organizes and incorporates under the Professional Service Corporation Act, Florida Statute Chapter 621, and Florida Statute 607 not in conflict therewith.

ARTICLE I - Name and Address

The name of this Corporation is: MARCIA STERN, P.A., and the principal place of business and mailing address is P.O. Box 741165, Boynton Beach, FL 33474-1165.

ARTICLE II - Commencement and Duration

This Corporation shall become effective on March 31, 2003 and the duration of this Corporation is perpetual.
