The undersigned, acting as incorporator to these Articles of Incorporation, a natural person competent to contract, hereby associates herself to form a corporation under the laws of the State of Florida.

ARTICLE I

<u>NAME</u>

NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:
